Motion to approve Director's reports was made by Dr. Tom Butler and seconded by Mr. Jack McCoy. The motion passed unanimously.

OLD BUSINESS

NBCE Part IV Schedule of Meetings and Exams

An email for the upcoming Part IV exam and Test committee schedules was brought back before the Board to consider sending a Board member to one or more of the scheduled dates. Dr. Thomas Taylor made a motion to send Dr. Dustin Heard to the Spring Exam on May 15-17. Dr. Kent Moore seconded the motion. The motion passed unanimously.

Clinic Ownership vs. License status

The Director posed a question of whether or not a Chiropractor could hold an Arkansas Active-out of state license and own a clinic here in Arkansas. This item was tabled from the last meeting so that the Board could seek the counsel of their attorney. According to the Boards attorney regarding this matter, the only requirement to own a professional corporation in Arkansas would be to have an Arkansas license; in addition, under the definition of practice of chiropractic in the ASBCE statutes it does not encompass clinic ownership. So, someone at this time could hold an Arkansas active-out of state license and own a clinic in AR. After further discussion a directive was given to Dr. Thomas Taylor to work on language regarding this topic.

Brian Verville, PT DPT

This item was forwarded to the PT Board for them to look into the matter of a PT possibly teaching manipulation in AR to Physical Therapists at one or more seminars he is speaking at. A response was received from the PT board on April 6, 2015 stating that "The Board reviewed the complaint at a board meeting on April 2, 2015 and determined no action would be taken. The course is approved by the Arkansas State Board of Physical Therapy but the approval does not imply that manipulation is within the scope of practice for Arkansas physical therapists. An Arkansas licensed physical therapist could take the course and benefit by other agenda items, including mobilization, which is within the scope of practice for Arkansas licensees." No other action was taken by ASBCE regarding this matter.

Part IV Language

A directive was given to Dr. Thomas Taylor at the January 22, 2015 meeting to work on language for Part IV and maybe a grandfathering clause. At this time, no updates were presented to the Board regarding the proposed language. This item was tabled for the next meeting in June.

Dr. Kent Moore questioned the board regarding the transfer of license process and that it may need to be updated as well since the requirements are similar to applying as a new licensee. Dr. Julie Traylor-Logan added that Dr. Moore's concerns would fall under the grandfathering clause that Dr. Taylor would be working on.

Dr. Traylor-Logan brought up that a recent applicant, who, in this case would fall under the transfer of license rule because the applicant didn't have the Physiological Therapeutics Exam. The Physiological Therapeutics exam at that time was an elective and his state did not require that particular exam. So, the applicant would not need the elective exam in order to make application with Arkansas. However, the applicant would have to take either the current state exam, or Part IV, or the SPEC exam in order to be licensed along with any other requirements needed.

NEW BUSINESS

Reinstatement request(s)

Dr. Eric Phipps submitted a letter to the Board requesting that his license be reinstated due to extenuating circumstances. The Board President allowed Dr. Phipps to address the Board regarding the reasons why he let his license lapse for 2015. After Dr. Phipps addressed the Board a motion was made by Mr. Jack McCoy to grant Dr. Phipps request to reinstate his license. The motion was seconded by Dr. Dustin Heard. Discussion followed by Dr. Thomas Taylor asking Dr. Phipps if he had been working while the license was lapsed. Dr. Phipps stated once he was notified he stopped practicing. All items have been received from Dr. Phipps at this time. The motion passed unanimously.

Second Appeal / Late fee waiver

A second appeal letter was submitted on behalf of Dr. Amanda Warren by Cleveland Chiropractic College which is who she took her CE through. A motion was made by Dr. Kent Moore to refund the late fee. The motion was seconded by Dr. Thomas Taylor. The motion passed unanimously.

Status Change request(s)

Dr. Russel Merrell submitted a status change request to move from Active-Out to State to Active (in state). Dr. Kent Moore made a motion to approve the Status change and the motion was seconded by Dr. Dustin Heard. The motion passed unanimously.

(Remaining New Business tabled to review credentials)

CREDENTIALS REVIEW (TEMPORARY LICENSES/EXTERSHIPS)

Dr. Gregory C. Schrader made application to the Board along with applying for a temporary license and therefore his credentials and temporary license applications were reviewed. Dr. Thomas Taylor made a motion to accept Dr. Schrader's credentials and grant him a temporary unsupervised license. Dr. Schrader will have to sit for Orientation in July. The motion was seconded by Dr. Kent Moore. The motion passed unanimously.

Dr. Justin A. C. Sutter made application to the Board along with applying for a temporary license and therefore his credentials and temporary license applications were reviewed. Dr. Thomas Taylor made a motion to accept Dr. Sutter's credentials and grant him a temporary supervised license. Dr. Sutter will have to sit for Orientation in July. The motion was seconded by Mr. Jack McCoy. The motion passed unanimously.

Dr. Olivia M. Fisher made application to the Board for the Extern program. Her preceptor's applications were also received from Dr. Traci Kiernan and Dr. Ben Pittman. A motion was made by Dr. Thomas Taylor to approve the applicant for the externship program. The motion was seconded by Mr. Jack McCoy. The motion passed unanimously.

NEW BUISNESS Cont.

Proposed Rules, Regulations & Statutes

The Board President had given a directive to Dr. Gaylon Carter and Dr. Chris Cathey to rework or come up with some new language regarding the regulation of Procurers and claims review. Proposed language was presented to the Board, which was discussed, and a motion made by Mr. Jack McCoy to approve some of the language with a second by Dr. Thomas Butler, but then the second and the motion were resended for further discussion. The Board President then gave a directive to the Boards Attorney to review the proposed language so that it fits in-line with the rest of the ASBCE Rules, Regulation and

Statutes. The President also gave a directive to the Executive Director to have an FCLB poll sent to all other states regarding claims review.

American Chiropractic Board of Sports Physicians

The American Chiropractic Board of Sports Physicians submitted a letter to the board asking what Arkansas rules are regarding Chiropractors evaluating, managing and determining return to play for concussed athletes. A directive was given to the Boards attorney to look into this matter prior to sending a response.

Zyto Brand Machine – Nutritional Analysis

Dr. Sidney Simpson submitted a letter to the Board regarding whether or not using a Zyto brand machine as a nutritional analysis tool was ok. He stated that the Board approved C.E. units for an instate seminar that this machine was presented at and is asking if this type of machine is within the Chiropractic scope of practice in the state of Arkansas.

A motion was made by Dr. Thomas Taylor that the nutritional analysis tool was in the scope of practice. Dr. Taylor's motion was not seconded and the motion failed. More discussion followed.

Dr. Tom Butler made a motion to approve that the nutritional analysis tool was in the scope of practice and the motion was seconded by Dr. Dustin Heard, but the motion and the second was rescinded. More discussion followed.

A third motion was made by Dr. Thomas Butler to agree that the Zyto Brand Machine as a nutritional analysis tool is in the Arkansas Chiropractic scope of practice. The motion was seconded by Mr. Jack McCoy. All others who voted in favor of the motion were Dr. Julie Traylor-Logan, Dr. Thomas Taylor, Dr. Dustin Heard. Dr. Kent Moore was opposed.

Letter to Board regarding Advertising

Dr. Sidney Simpson submitted a letter to the Board inquiring about advertising discounts and publishing coupons for discounted services. The Board President gave a directive to the board's attorney to review Dr. Simpson's specific questions to see if they would be in violation of any of the advertising or billing rules, regulations or statutes.

Osteopractor - Advertising

An advertisement was brought to the Board's attention regarding an Osteopractor, who is also a licensed Physical Therapist, which was advertising manipulation on her website. After a short discussion by the Board Dr. Thomas Taylor made a motion to forward this to the Physical Therapy Board, but then rescinded it. More discussion followed. Dr. Taylor then made another motion to forward this to the PT Board for them to investigate it further. The motion was seconded by Mr. Jack McCoy. The motion passed unanimously.

Chiro-Trust.org

An email was received from a Larry Froncek with ChiroTrust. He asked if they added a "Find a Chiropractor Near You" type section where consumers can type their zip code in to find a DC near them who has taken the ChiroTrust pledge, would they need to register their site as a referral service with the Board. Dr. Thomas Taylor made a motion to request the pledge from ChiroTrust for further review. He then amended his motion to include all relevant material including contracts and obligations the DC would have to follow. Dr. Thomas Butler seconded the motion. The motion passed unanimously.

NBCE Test Committee Nominations

A reminder from NBCE was received regarding nominations for the upcoming Part IV exam test committee meeting on June 12th and 13th. Dr. Thomas Butler made a motion to approve Dr. Heard or Dr. Moore to attend depending on their schedules. The motion was seconded by Dr. Tomas Taylor. The motion passed unanimously.

Dr. Julie Traylor-Logan, Board President, wanted to get an update on the Board's vacant position and title verification on the Boards public members.
