### Sales to Minors Enforcement Fiscal Year 2008 Annual Summary

### **Summary of Accomplishments**

Our violation rate for 2008 shows to be the lowest yet. We feel this is a result of increased compliance checks and merchant education. We are hoping that with the increased compliance checks, merchant education and routine inspections the rate will decrease even more. During the year, we performed 5,022 compliance checks with only 319 violations. This results in an average of 6.35% for the year compared to 7.42% the previous year.

We have seen drastic improvements in our annual violation rates since we first began conducting compliance checks in April, 2002. A breakdown of our annual rates is as follows:

Since we began merchant education classes in 2004 here is the break down of the trainings:

Overall, our merchant education classes are showing signs of tremendous success. Classes in most areas continue to be well attended and feed back continues to be very positive. During our merchant education classes we hand out an evaluation form for each attendee to fill out. We are using the feed back to improve our training. This is the response we have received.

We look forward to the new year. Through a combination of enforcement and education, Arkansas will continue to see improvements and be among the elite states in the nation in reducing youth access to tobacco.

#### **Summary of Barriers**

Issues we have faced in FY08 in merchant education is the lack of interest in the southern part of the state for training. We have held several trainings in that area through out the year and have not had a good response even cancelling one due to no response. We are going to perform saturations in that area in FY09 and then hold trainings immediately afterward to see if we get a better response.
