 - e. Level 2 Users **shall** only have access to Level 1 User data Assigned to them from Level 3 Users.
- Add the following to Section 2.2 (A) 4. Guest Users:

Guest Users are individuals not affiliated with a local education agency (e.g. school district, adult education center, or institution of higher education).
- Add the following to Section 2.5 (C) PUBLIC RELATIONS/MARKETING:
 - Marketing materials may be submitted electronically with the ability for the State to reproduce.

CHANGE OF SPECIFICATIONS

- Delete 2.3.C.3 and replace with the following:
 - 3. The system **shall** enable local career counseling staff to create personalized college-readiness plans that link Users skills and areas of interest to their college and career goals. Skills may be found at <http://www.onetonline.org/find/descriptor/browse/Skills/>
- Delete 2.3.F.3 and replace with the following:
 - 3. The system **shall** provide electronic document delivery for transcripts and letters of recommendation to include Common App Schools. The system **must** provide a link to Youniversal application process.
- Delete 2.3.F.3 and replace with the following:
 - 3. The system **shall** provide access to local, state and regional labor market data, at least, quarterly.

- Delete 2.3.G.6 and replace with the following:
 6. ACE, ADE, Department of Workforce Services (DWS), and Arkansas Economic Development Commission (AEDC) have data systems which house education and employment information. At a minimum, the vendor's system **shall** be compatible with these State systems, through utilization of an API, so that it **shall** be able to interface and download data from these systems. These State systems include:
