1.1 AWARD PROCESS

A. Successful Contractor Selection

1. Award will be made to the lowest-bidding, responsible Prospective Contractor on an ALL OR NONE TOTAL basis for items 1-15. Consideration will be given only to those who bid all line items.

- **Delete Section 1.9 SUBCONTRACTORS and replace with the following:**

1.9 SUBCONTRACTORS


- A. Prospective Contractor should complete, sign and submit the *Proposed Subcontractors Form* included in this Addendum.
- B. **Do not** attach any additional information to the *Proposed Subcontractors Form*.
- C. The utilization of any proposed subcontractor is subject to approval by the State agency and have the option to replace any subcontractor who becomes incompatible with the agency. The agency will be the sole judge of the incompatibility.
- D. Subcontractors of the Contractor **must** abide by the same requirements of any resulting contract that is issued to the Prime Contractor.

- **Delete A. #3 from Section 2.2 and replace with the following:**

3. Contractor, employees of the contractor, and subcontractors of the Primary Contractor should utilize vehicles dedicated to transporting of biological specimens and/or supplies.
 - Vehicles engaged in the transportation of specimens **must** be identified with either permanent placards or magnetic signage with the name of the company and phone number.
