



## The Home Depot U.S. Communities Partnership MRO Contract #05091 Overview

### Benefits of the Partnership

- No cost to participate
- No minimum spending requirement
- Access to competitive pricing at all U.S. Home Depot stores
  - Only online purchases and in-store purchases through the contractors desk are eligible for pricing discounts
- Volume pricing on orders over \$2500 through the Home Depot Bid Room (up to 17% discount)

- Rebate incentives will be returned to agencies annually
- Ability to view statements, print invoices, make payments, and check account balance online at <http://www.homedepot.com/credit>
- Ability to buy in-store or online:
  - Approximately 19 stores in Arkansas
  - You can use a P-Card or P.O (with in-store acct) at any U.S. Home Depot location
    - In-store accounts are also eligible for rebate incentives
- Any public agency, up to but not including the Federal Government is eligible

**The following are NOT to be purchased through Home Depot due to mandatory state contracts:**

- Air Conditioners/Heat Pumps
- Lamps/Lamp Ballast

**Please note: Please contact ABA if you are going to contract labor for \$20,000 or more and are under ABA guidelines.**

### HOW TO REGISTER

**ALL agencies must register their P-Cards and in-store accounts through the online registration process. If you don't they will NOT be eligible for rebate incentives.**

**Step 1:** Visit the Office of State Procurement's website for registration instructions

**Step 2:** Register online for the U.S. Communities Home Depot Program

**Note:** ALL P-Cards used for Home Depot purchases must be registered to provide tracking for potential rebates

**Step 3:** Register online for a Home Depot Commercial Account

**Note:** ANY Home Depot purchases that are non P-Card related must use a Home Depot Commercial Account to provide tracking for potential rebates
